- Summer Wavebuck\$ and NOLAbuck\$ will expire on Saturday, August 9, 2025.

TERMS AND CONDITIONS

- **Student must have charging privileges in accounts receivable for Dining Services to bill the student, otherwise, the dining plan must be pre-paid for at the Bursar's Office and then this form must be brought to Campus Services, LBC 107.**
- The dining plan charge appears on the student's Accounts Receivable statement. Payments may be made at the Bursar's Office, 1030 Audubon Street, New Orleans, LA 70118-5549. Information on student accounts may be obtained from Accounts Receivable (acctrec@tulane.edu or 1-800-798-7633). Please do not mail payments to Dining Services.
- Any attempt to fraudulently use the dining plan of another student will result in disciplinary action against both parties. Lost Splash Cards are replaced at the Campus Services office for a fee. **Food and equipment (including dishes & flatware) may not be removed from the Dining Room at Malkin Sacks Commons or Green Wave Grille. The Dining Room at Malkin Sacks Commons and Green Wave Grille are "dine in" only facilities.** Violations of this rule are brought before the University Disciplinary Board. Disruptive behavior, destruction of property or violation of any university policy or code of conduct will result in sanctions through the University Disciplinary Process. Such sanctions may include but are not limited to, barring a student from participating in the dining plan without a refund.
- **ANY CHANGES IN DAYS OR HOURS OF OPERATION WILL BE UPDATED ON WWW.DININGSERVICES.TULANE.EDU.**
- Requests for changes or cancellations must be made in person at the Campus Services office, LBC 107. Refunds are made in the form of a credit to the student's Accounts Receivable account.
- There are no refunds of dining fees except when a student withdraws from classes before a previously established deadline. In such a situation, a student may receive a 100 percent refund for dining plan if withdrawal occurs prior to the dining plan starting on June 8, 2025.
- There is no refund of dining fees for students who withdraw from the university as a result of suspension or dismissal.
- Tulane reserves the right in the case of natural disaster, pandemic flu, or other catastrophic events where Tulane must cease operation for a single semester or significant portion of a semester to modify its no-refund policy. The modified no-refund policy would be determined solely at the discretion of the university administration.
- Cancellations of a dining plan by the deadline will be charged on a prorated daily basis through the date of cancellation regardless of whether any meal swipes are used. Failure to participate in the dining plan does not automatically release a student from the student's dining contract. Cancellation will include a \$75 administrative fee.
